Expression of Interest for Running Cafeteria at the National Institute of Technology Goa Campus

The National Institute of Technology Goa (NIT Goa), Cuncolim, is an "Institute of National Importance" functioning under the Ministry of Education, Govt. of India. NIT Goa is willing to run a cafeteria with standard quality food to improve food variety for students, staff, and faculty members at Cuncolim, Goa.

NIT Goa wish to open a Cafeteria with all facilities, including food, tea & coffee, soft drinks, etc., from reputed national and international brands and stakeholders/ authorized agencies/franchises. Sealed Expression of Interest (EOI) is hereby invited from the interested bidders for "Operation of Cafeteria" at NIT Goa, Cuncolim, South Goa – 403703, Goa. Bidders can also download this document from the Institute's Website (www.nitgoa.ac.in) and submit their EOI in the format duly filled out and signed with company seal with required enclosures and documents.

The EOI is to be submitted in a sealed envelope super scribed "EOI for Operation of Cafeteria at NIT Goa" addressed to the Registrar, NIT Goa or may be submitted directly to the dispatch section, administrative building, NIT Goa Campus.

Section I

INSTRUCTION TO BIDDERS / TERMS & CONDITIONS:

BID-SECURITY/EMD:

"BID SECURITY" (also known as Earnest Money Deposit (EMD)) as a Demand Draft should be submitted safeguarding the purchaser's interest in all respects.

The bidder shall submit an EMD of ₹5,000/-. Non-compliance to this term leads to rejection of the bid.

The EMD will be forfeited if the bidder is not in a position to accept the service order/Work order issued as a result of this tender/deliver the services after the award of the service order/Work order as per the stipulated terms and conditions of the tender document.

EMD of unsuccessful bidders will be returned after the tender process is completed upon receipt of a request to release the same.

EMD of the successful bidder is to be returned after the submission performance guarantee only.

PERFORMANCE GUARANTEE:

"PERFORMANCE SECURITY" (also known as Performance Bank Guarantee (PBG)) shall mean Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt from a Commercial bank, Bank Guarantee (including e-Bank Guarantee) from a Commercial Bank in an acceptable form safeguarding the purchaser's interest in all respects.

PBG shall be four (4) months' rent (e.g. If the monthly is ₹10,000, then PBG shall be 4*10,000 = ₹40,000/-). The successful bidder should submit PBG within 20 days from the issuance of the work order.

The Performance Bank Guarantee so deposited shall be liable to be forfeited or appropriated in the event of unsatisfactory performance of the Contractor and/or loss/damage if any sustained by the Institute on account of failure or negligence of worker deployed by the Vendor or in the event breach of the agreement by the Contractor.

The Performance Bank Guarantee will be refunded to the Contractor within two months of contract expiry only on satisfactory contract performance and settlement of all dues whichever is late upon submitting a request to release the same.

Other Instructions:

This EOI invitation document is not a Tender or Request for Proposal in any form and would not be binding on NIT Goa in any manner whatsoever.

The Interested parties must submit a presentation showcasing the range of foods/products/items sold, along with price list, existing ventures, if any, at other educational institutions, residential campuses, etc. This will be one of the shortlisting criteria, among others, as mentioned in Section III, point number 33.1.5 (Also, see, SNo. 9, Annexure II)

NIT Goa reserves the right to cancel the EOI invitation as a whole or in part without assigning any

reason whatsoever.

The interested parties are encouraged to conduct their own independent survey, assessment, and analysis and check the reliability, accuracy, feasibility, and completeness before submitting their interest/ proposal.

NIT Goa reserves the right to update, amend, and supplement the information given in this document at its sole discretion before the last date and time of Submission of the interest/proposal.

The following facilities are to be extended by the Institute:

The Institute will provide space (As mentioned in EOI) to run the facilities at a designated location.

The Institute will provide metered Electricity and Water Connections. If the meter is unavailable, a fixed amount should be deposited into the institute account after mutual consultation with the Commercial Establishment Monitoring and Management Committee (CEMMC). After the meter installation, the actual amount will be calculated on a pro-rata basis.

The service provider shall use only the space earmarked to operate the facility and shall not use any other space for any other purpose.

The rent will be charged based on the successful bidders' quoting.

The services shall be open to the Institute beneficiaries only. As such, the vendors (service providers) shall neither invite/entertain any users from outside at or around the allotted space. Violation of this expressed condition shall automatically result in termination of the contract.

No child labourers shall be employed for servicing as per the law.

If found quarrelling or misbehaving with anyone or involved in any anti-social activity, the Institute will cancel the contract agreement. In such a situation, the agency has to vacate the premises within 3 days.

The service provider shall raise a proper invoice for every service rendered.

No item shall be sold above MRP.

Bidders should submit their responses in Annexure-I format. The Institute shall reject the EOI if it does not conform to the instructions or prescribed formats.

Bidders should equip themselves with all the permits, licenses, etc. required to operate the Cafeteria.

Bidders should adhere to all the safety guidelines and norms when running the Cafeteria.

The bidder will be responsible for cleaning and regular upkeep of the premises.

The contract term will be initially for one (01) year, renewable annually for another four (04) years, and the same may be extended on satisfactory performance. On expiry of the contract term, the Bidder shall vacate the premises immediately. However, the existing operator may Bid fresh if not prohibited otherwise due to unsatisfactory performance.

The extension as stated above will be subject to the acceptance of a hike in rent by 5% annually,

among other things.

The Service Provider shall start operating the work/services within Six weeks from the date of the sanction order and shall not carry its business in any other part of the premises.

A committee constituted by the Institute, the Commercial Establishment Monitoring & Management Committee (CEMMC), will make surprise visits/ monitoring of the services rendered by the agency/service provider.

The Service Provider shall obtain permission from CEMMC before modifying structures/installing counters and fixtures/ revising the menu etc...

If the Service Provider does not vacate the allotted space/building after the expiry of the license period or after one month of notice period of termination of the Agreement, the agency is liable to pay a daily penal rent of Rs. 1000/- in addition to the other charges as applicable.

No liquor/smoking/any other items intoxicating or prohibited by law shall be provided/ served in the Cafeteria.

The selected Bidder will have to sign an Agreement with NIT Goa before starting the operation of the Cafeteria.

NIT Goa reserves the right to call limited/shortlisted or all parties to make a presentation based on their experience and technical Submission made in the EOI. Mere fulfilment of EOI criteria does not entail the parties being called to present.

In support of the credentials submitted by the parties, NIT Goa reserves the right to solicit information from the organizations by telephonic verification / personal visits / in writing.

Interested bidders may attend a Pre-Bid meeting on the date and time mentioned in the schedule.

Termination of Contract: The Contract can be terminated on serving notice by either party. The notice period is as below:

29.1 The service provider/contractor may terminate his contract with NIT Goa for any reason by issuing a notice. The notice period for termination of the contract shall be four months by the service provider.

29.2. The National Institute of Technology, Goa reserves the right to terminate the contract at any point of time during the tenure of the contract, if the services are not found satisfactory or for other reasons. The notice period for termination of the contract shall be Two months by NIT Goa.

29.3. In case of misbehaving with anyone or being involved in any anti-social activity, the Institute will cancel the contract agreement immediately. In such a situation, the agency has to vacate the premises within 3 days.

Section II SCOPE OF WORK:

Preliminary Work

30.1. To prepare and provide Tea, Snacks, Juices and other Food products, in the Cafeteria from 8.30 am to 6.30 pm (can be extended up to 10.30 pm) on all days, including Sundays and Holidays. 30.2. To provide good quality food, products and services to all customers/consumers promptly and efficiently.

30.3. To undertake catering & supply of Tea/Snacks, juices and other foods on an order basis for various programmes/events of the Institute as and when required.

30.4. To ensure the cleanliness of the Cafeteria and its premises.

Mandatory Requirements:

- 31.1. The contractor /agency shall place specialized and trained staff for cooking and supervision, service, catering, helping jobs, etc.
- 31.2. To ensure Self-service in the Cafeteria for all Customers, except when catering for meetings/conferences, etc.
- 31.3. Ensure that Cook(s), Waiters and Helpers are dressed in proper uniform and trained to be courteous and provide quality service.
- 31.4. Ensures that Cafeteria/Catering Managers behave promptly and efficiently.
- 31.5. Avoid overpricing and escalation, fix and display the Rate per item of Food & Snacks, Lunch/Dinner, Combo meals, beverages, etc., in consultation with CEMMC.
- 31.6. Provide cooking utensils, cutlery, crockery, commercial gas cylinders, stove, refrigerator, etc., as necessary for running and maintaining the Cafeteria.
- 31.7. Ensure that single-use plastic items are not provided in the Cafeteria.
- 31.8. Maintaining the cafeteria premises and keeping them clean at their own cost.
- 31.9. Ensure proper maintenance of the Cafeteria and all infrastructure, and fixtures.
- 31.10. Sub-leasing of the Cafeteria after the award of work/Agreement will not be permitted.
- 31.11. The Bidder/Contractor/Agency will be required to consult CEMMC before advertising anything related to the Cafeteria in the print media.

Section III

Eligibility Criteria:

- 32.1. The Bidder should have been operating in the hospitality sector for at least three years (Hospitality would include experience in the service industry, including lodging, dining/restaurant, event management, theme parks, and hotels).
- 32.2. Institutions of national and international repute in hospitality shall be preferred.
- 32.3. The Bidder should have experience in catering and maintaining a cafeteria.
- 32.4. The Bidder should have been operating and managing a similar size and scale project for the last 3 years.

34.3. Record of poor performance such as abandoning work, not properly completing the contract, financial failures/weaknesses, etc.

While submitting the Expression of Interest for the Cafeteria (on the letterhead of the firm according to the format in Annexure – I), the Bidder must submit the details along with all required supporting documents showing their experience, list of food items etc. (Annexure-II), without which the bid will not be considered.
