NIT Goa received sanctioned posts in 2013 vide Ministry letter no. 24-2/2010-TS.III dated 21.06.2013, and since then no additional posts were sanctioned. The current sanctioned student strength is 972 as per the sanctioned student strength the desired number of teaching post is 97 (1:10 faculty student ratio) whereas current sanction is only 38. Similarly, the desired number of non-teaching post is 107, whereas current sanction is only 42. Additional desired sanction required is 59 Teaching posts and 65 Non-Teaching Posts

The breakup of the desired additional post in the prescribed format of IFD is placed in Annexure BoG 38.A3.

BoG is requested to approve the same.
