NIT Goa was established in the year 2010 by an act of parliament (NIT act 2007) and it is declared as 'Institute of National Importance'. The Institute offers under Graduate courses in Five Engineering Departments: CSE, ECE, EEE, CVE, and MCE. The Institute offers Ph.D. degree in five Engineering Departments, as well as Physics, Chemistry, Mathematics, Economics and English specializations. The Institute also offers M.Tech. Programmes in CSE, VLSI and PEPS. **Applications are invited for admission into Full-time Self-Financed (Non-GATE) M.Tech Programme and Extra Spot Round in the following Departments for the Academic year 2023-2024.**

Information for Self-Financed (Non-GATE) M.Tech

<u>Minimum Qualification/Eligibility:</u> Admission shall be open to Indian nationals who have passed B.Tech/B.E. with 60% aggregate or 6.5 CGPA (in the 0-10 point scale grading system) for GEN/OBC/EWS category and minimum 55% aggregate marks or 6.0 CGPA for candidates under SC/ST/PwD category.

<u>No Scholarship:</u> The student who is selected under Full-time Self-Financed (Non-GATE) category will NOT receive any scholarship/financial assistance from NIT Goa.

Selection Procedure:

- Selection of candidates for admission to Full-time Self-Financed (Non-GATE) M.Tech programmes will be based upon the academic performance in the qualifying examinations (B.Tech/B.E.), written test and interview with due weightage for each component as specified by the concerned department. Mere call for Test and Interview does not guarantee admission.
- List of shortlisted candidates will be published in Institute website. No Call Letter will be sent through surface mail/email. Visit Institute website: www.nitgoa.ac.in regularly for more details and updates.
- Separate application has to be submitted to each department in case a candidate applies to multiple departments.

How to Apply:

- Downloadable application form is available in the Institute's website: <u>www.nitgoa.ac.in</u>
- The application form must be filled in all respects or else it will be treated as cancelled.
- Each applicant has to pay a registration fee of ₹3,000/- for GEN/GENEWS/OBC and ₹2,500/- for SC/ST/PwD per application. Applications to more than one department shall be considered only upon payment of the requisite fees for each department. Application fee is non-refundable.
- The application fee payment should be made through online mode only, on or before the last date 14-08-2023.

Information for Extra Spot Round (with Valid GATE Score)

Eligibility: Candidates seeking admission to take M.Tech. degree programme through Extra Spot round Admission at NIT Goa will be as per the **CCMT 2023 norms.**

NOTE: Candidates, who have already been admitted to an institute through CCMT-2023, are not eligible for this Extra spot round admission. However, if they wish to participate, they have to cancel their admission prior to their reporting and registration for NIT Goa's Extra Spot round.

Registration for Extra Spot Admission: The eligible candidates should register for extra spot admission in person on **21-08-2023 (Monday) between 09.00 AM to 12.00 Noon**. Those who come after 12.00 Noon will not be allowed for registration.

Selection Procedure: Seats will be allotted to the eligible candidates based on GATE score (2021, 2022 & 2023) only. In case of candidates having same GATE score, following criterion will be used in the stated order of preference.

- Candidates having GATE score in 2021 will be given preference over candidate having score in 2022 and 2023. Candidates having GATE score in 2022 will be given preference over candidate having score in 2023. If year of GATE score is same then preference will be given to that candidate who obtained higher GATE marks out of 100.
- In an unlikely event of their GATE marks out of 100 and the year of GATE score being the same, then preference will be based on the All India Rank (AIR).
- In highly unlikely event of the candidates having same GATE Year, GATE marks out of 100 and AIR then Date of Birth will be considered. Elder candidate will be given preference.

Original Documents: In case a candidate gets a seat, he/she has to pay the institute fee and produce the following documents in original for verification on the same day, failing which his/her seat allotment will be cancelled and that seat will be allotted to the next waiting list candidate.

- i. Valid GATE score card
- ii. Original Birth certificate (in English or Hindi) as proof of date of birth
- iii. Original Class X Board Certificate
- iv. Original Class XII certificate
- v. Original Statement of Grades/Marks obtained in the qualifying Examination
- vi. Original Degree / Provisional Certificate
- vii. Original Course Completion Certificate for result awaiting candidates
- viii. Original Transfer Certificate issued from the institute last studied/attended
- ix. Original Migration Certificate

x. Original Certificate of Category (EWS/OBC-NCL/SC/ST), if applicable, issued by the competent authority as per the prescribed format given in ANNEXURE.

xi. (EWS/OBC-NCL category certificate must be issued on or after 01.04.2023). Undertaking for Caste Validity certificate for Maharashtra State Candidates

xii. OBC-NCL undertaking form for OBC-NCL candidates as given in in ANNEXURE. xiii.Original Certificate for Persons with Disabilities (PwD) issued by Medical Board notified under PwD Act.
