Board authorised Director, NIT Goa to invite any suitable eminent person as Chief Guest for first convocation in consultation with the Chairman BoG, if the President of India declines the invitation.

C.1 Ratification of FC Items

C.1.1 Reporting Item

Construction of temporary shed for conducting workshops and drawing classes of NIT Goa.

The workshop and drawing classes of NIT Goa were functioning earlier in class rooms of ITI. However, the principal of ITI has declined to extend the facility to NIT Goa from the next semester due to logistic reason and disparity of time schedule. As a result, it became imperative on the part of NIT to have its own facilities for conducting workshops and drawing classes.

Fortunately, some open space is available for the said purpose in the temporary premises of NIT. CPWD is requested to give the estimation as the job as already been assigned to CPWD and has also been instructed to complete the job by 5th January 2014, before the commencement of the next academic session.

The preliminary estimate given by CPWD is Rs. 31,07,778/- for the said work. The copy of estimation submitted by CPWD would be tabled.

Board took note of the item reported. Board considered the suggestion of FC, to put a false-ceiling in the structure of Drawing Class room even if there is a marginal increase in the cost of construction..
