In case, the day of submission of the quotation happens to be a holiday on account of Govt. notification or weekends and quotation cannot be received or opened, the quotations shall be received on the next working day at **01.00 P.M. and will be opened on same day at 02.00 P.M.** for which no separate communications will be made. Other terms and conditions are enclosed.

Instructions to bidders

The bidders should submit the quotation along with mandatory documents to Inward section NIT Goa (Administration office, Main Building) and the envelope should be superscribed as Quotation Enquiry No. NITGOA/CONV 2023/PUR/OW/ 351 dated 08/09/2023 for the **Transportation Service for 9th Convocation 2023**.

1. The quotation should be addressed to **"The Director, NIT Goa Farmagudi Ponda Goa 403401"**.
2. The rates should be quoted both in figures and words and legibly written without any over-writings. In case of any correction, the same must be attested by the bidder with a full signature.
3. In case of any discrepancy between the rates in figures and that in words, the rate in words will be accepted as correct.
4. The last date for receipt of the quotation is marked in the inquiry. In case the above date is declared a holiday for NIT Goa, and the bids will be received up to the appointed time on the next working day.
5. The quotation may be sent by post, to reach the office NIT Goa before the last date of receipt, or be submitted in the office of the normal working hours of the Institute. **(09.00 A.M. to 05.30 P.M.)**
6. Intending quotationeres requires any clarification regarding the notice inviting quotation, he may mail to **shangerganesh@nitgoa.ac.in** at least **01 days** before the last date quotation submission time.
7. Quotation submitted after the last submission date will not be accepted and his quotation will be treated as non-responsive.
8. Intending quotationeres shall submit only one quotation. A quotationeres, who submits more than one quotation, shall be disqualified and considered non-responsive.
9. The quotation shall be opened by the committee in the NIT GOA at the date and time given on the top of the document. The quotationeres may send their authorized representatives to attend the quotation opening with proper authorization letter if they so desire. In the event of the above quotation opening date being declared a holiday for the NIT Goa, then the bids will be opened at the appointed time and place on the next working day.
10. **The quotationeres have to put a seal and sign in full at all pages of the quotation notice including all annexures and price bid failing which the bidder will be disqualified.**
11. Director NIT GOA has the right to reject any or all the quotations received without assigning any reason thereof.

- 12.If the offered item covers the warranty period it has to be mentioned by quotationere in the quotation. (Certificate should be provided). Failing to provide the Product service during the warranty period will entitle the firm/proprietor debarment from NIT Goa Procurement.

Conditions of the participation in quotation

1. The rates quoted should preferably be net, inclusive of all taxes and duties, packing, forwarding, freight, Insurance, training cum demo charges (if any), and all other incidental charges mentioned separately.
2. **The transportation has to be arranged and it will be required from 12th October – 15th October 2023.**
3. The bid should remain valid for **45 days** from the date of opening.
4. Conditional discount, if any, offered by the bidder shall not be considered at the time of evaluation.
5. The good/service offered should strictly conform to the specification and technical details mentioned in technical specification by NIT GOA.
6. Any Liability regarding GST will be of the supplier of products. Also, any obligations regarding Indian Acts will be the responsibility of the supplier of products only.
7. If the successful bidder, on receipt of the supply order, fails to execute the service within the stipulated period, in full or part, it will be open to the Director, NIT Goa to recover liquidated damage from the firm at the rate of 0.5 percent of the value of undelivered goods per week or part thereof, subject to a maximum of 10 percent of the value of undelivered goods beyond the due date for delivery. Alternatively, it will also be opened to the Director NIT GOA to accept the part supply by the contractor and arrange to procure remaining items from other modes as per GFR 2017 Rules.
8. Payment (As per goods supplied, after deduction (if any)) will be made by Wire transfer within 30 days from the installation (if any) or receipt of the goods in good condition or receipt of the bill, commissioning of the equipment, where applicable, whichever is later/latest.
9. In the event of any dispute arising out of the quotations or from the resultant contract, the decision of the Director, NIT Goa shall be final.

10. Any disputes arising out of this inquiry shall be dealt with in the Goa jurisdiction only.

Special Terms and Conditions

- a) The vehicles should have valid permits and other requirements.
- b) The vehicles provided should be authorized to be used as taxis/buses and have proper permission for the areas to be travelled in Goa.
- c) The drivers engaged in the Taxis/Buses should have valid driving commercial licenses to operate the taxi/bus issued by the Transport Authorities' and other necessary certificates like Road Tax clearance, pollution certificate, etc., should exist for all vehicles quoted.
- d) The Vehicles on duty must be kept in clean condition. The general condition of the vehicle provided should be good. The seat should be comfortable. The seats shall always be covered with neat and good quality seat covers. No payment shall be made if the vehicle is found in dirty or shabby condition.
- e) In case of hiring a Taxi, 24 hours or 250 km (whichever occurs earlier) shall be considered a full day.
- f) Additional charges will be paid if the vehicle travels more than 250 km in a day. Payment shall be made for the extra kilometres at the pro-rata basis beyond 250 km.
- g) In case of hiring a Bus, round trip to NIT Goa, Farmagudi - Cuncolim Campus - NIT Goa, Farmagudi only shall be considered for rent. This trip will be considered for full day.
- h) Vehicle type: SUV for Taxi. For Eg. Innova, Ertica, Brezza or similar vehicles.
- i) Bus with minimum 40 seater capacity.
- j) Price should be inclusive of all applicable taxes and other charges.


- k) The Service Provider/Agency providing Taxi and Bus Service for Convocation-2023 should follow all the Rules and regulations of the state and central Government about the procurement.
- l) The NIT Goa reserves the right either to increase/decrease the quantity mentioned in Tender by 25 percent (rounding off to the nearest quantity).

Criteria for Evaluation of Lowest Quotation:

- a) The bidder has to quote for all the items mentioned in the price bid. Failing to quote for one or more than one item will result in the disqualification of the quotation. (Quotation to be submitted on the firm letterhead mentioning GST No., PAN no. of Firm/Proprietor.)
- b) The Agency/Service Provider/Bidder shall have its office in Goa. (Proof to be enclosed).
- c) The agency must have all applicable tax registrations (GST, PAN etc.) supported by documentary evidence. Signed and stamped copy of the entire quotation notice along with a copy of GST Registration Certificate and PAN card to be submitted by the bidder.
- d) After fulfilling the criteria mentioned above, the quotation which is lowest in Total (of all items) will be awarded the order.




