* The Document verification will start at 9AM hence, all the candidates shall report as per the scheduled reporting time.

Instructions to Candidates:

1. Trade/ Skill Test is of qualifying nature, for which a minimum score of 50% is required to pass for UR candidate, 45% for OBC (NCL) and 40% for SC candidates.
2. Trade/Skill test will comprise of questions of objective / subjective type based on theory and experimental setups, as per given syllabus, to assess the skill and practical knowledge in the particular stream or branch. Candidate will have to give the answers of these questions in writing.
3. The Level-I marks shall be considered for preparation of the merit list, only for those candidates who qualify the Skill Test (Level-II).
4. ***The selected candidate must give their choice of the stream/ department/Branch / trade where she/he is willing to appear for the trade / skill test in the google form (to be shared via registered email-id) on or before 22/04/2026 up-to 05:00 PM. If candidate does not fill the google form within stipulated time-frame, her/his candidature may not be considered for the skill/trade test. In case of any query please send email to recruitment@nitgoa.ac.in***

The candidates are advised to fill their option carefully only once.

5. The candidature is PROVISIONAL. If at any stage it is found that any applicant does not fulfill any of the conditions of eligibility, her / his candidature will be cancelled and no appeal against such cancellation will be entertained. The fact that she / he has been called for the test does not confer any right on her / him to be treated as eligible in all aspects for appointment or to be considered for the test.
6. No TA / DA for attending the test will be provided.
7. No candidates shall be allowed to enter the institute without a Hard copy of e-Admit Card supported by valid ID Proof.
8. It is to be noted that Mobile Phones or any electronic gadgets will not be allowed inside the exam hall. The institute will not be responsible for keeping any mobile or any electronic gadgets or any associated loss of mobile / electronic gadgets.
9. All the eligible candidates have to produce following documents at the time of document verification.
 - a) The original certificates for their educational qualification and relevant experience mentioned in their application form.
 - b) Proof of Identity issued by the Govt. (in Original) such Aadhar Card / Passport / Driving License / PAN Card / Voter Card.
 - c) The person working in a Government, Semi Government, Autonomous organization including Public Sector Undertakings etc. and whose application has not been forwarded through proper channel by the employer will be required to bring a 'No Objection Certificate' along with 'Vigilance Clearance Certificate'

from the present employer. In the absence of No Objection Certificate and other certificates their candidature will not be considered.

- d) Applicants must ensure to carry valid caste certificate as per the GoI Norms.
 - e) The applicants must ensure the compliance of the instructions mentioned in the Advertisement NITGOA/Rect./2025/OW/01-11 dated 28/03/2025.
10. The Number of posts shown in Advt. may change and may vary at the time of selection/recruitment. The Institute reserves the right not to fill any/ all posts advertised and to reject any/all application without assigning any reason.
11. The selected candidates against the respective posts shall be posted or can be transferred to in any of the following centres/ departments from time to time as per the requirements of the Institute: **Civil Engineering/ Computer Science and Engineering/ Electrical and Electronics Engineering/ Electronics and Communication Engineering/ Mechanical Engineering/ Physics/ Chemistry/ Estate Office etc.**
12. Mere appearance in the Written Test / Skill Test OR qualifying in the test doesn't entitle a candidate to be considered for selection unless candidates fulfill the eligibility conditions. APPLICANTS MUST FULLY SATISFY ABOUT THEIR ELIGIBILITY AS PRESCRIBED IN OUR WEBSITE, BEFORE APPEARING IN THE TEST. If a candidate is inadvertently allowed to appear at the test who otherwise doesn't fulfill the minimum eligibility requirements, the candidate cannot, at a later date, use that as a right to claim that candidate meets the eligibility requirements. The Institute reserves the right not to allow a candidate for selection if it is found that
- a) Minimum eligibility requirements are not fulfilled.
 - b) Inadequate proof / false documentation has been done.
 - c) Non-submission of valid NOC
 - d) Any other similar valid reasons.
